SEND GREETING:

WHEREAS, *I* the said *E. C. Honour*

in and by *me* certain promissory note in writing, of even date with these presents, well and truly indebted to AMERICAN BUILDING AND LOAN ASSOCIATION, a corporation incorporated under the laws of the State of South Carolina, in the full and just sum of *one hundred and 20/100* Dollars,

to be paid on or before the date when the *30th* Series of the *Installment*

Stock of the said AMERICAN BUILDING AND LOAN ASSOCIATION shall reach maturity, with interest thereon from date at the rate of eight per cent per annum payable weekly, on or before Saturday night of each and every week, until paid in full; and if *I*

fail to pay said interest or to comply in all respects with the By-Laws of said association, for the space of thirty days, then said debt shall become immediately due and payable, together with all interest, fines and expenses, and all amounts advanced by the said Association on the within described property, by way of taxes or insurance, the same to be added to the amount due on said note and to be collectible as part thereof, together with an attorney's fee of ten per cent. if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof be collected by an attorney, or legal proceedings of any kind (all of which is secured under this mortgage, as provided in and by the said note, reference being thereunto had, will more fully appear.

NOW, KNOW ALL MEN, That *E. C. Honour* the said *E. C. Honour*

in consideration of the said *debt* and sum of money aforesaid, and for the better securing the payment thereof to the said AMERICAN BUILDING AND LOAN ASSOCIATION, according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to *me* the said *E. C. Honour*

in hand well and truly paid by the said AMERICAN BUILDING AND LOAN ASSOCIATION, at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said AMERICAN BUILDING

AND LOAN ASSOCIATION *in west Greenville, and being known*

and designated, as Lot No. 1 on Plat of Brundage Annex, which is recorded in the *S.D.C.* office for Greenville County in *Book C, pages 218 + 219*, and having the following meter *bound* bounds to-wit:

Beginning at a stake on the North side of Puddleton Road, joint corner of Lot No. 2, and running thence with *new road (recently made)* in a northeasterly direction 75.6 feet to a stake, corner of a street adjoining "Ponewood"; thence with said street in a northerly direction 103 feet to a stake at corner of Lot No. 12; thence along line of Lot No. 13 N. 71 W. 4.4 feet to a stake, corner of Lot No. 2; thence along line of Lot No. 2 S. 25-30 W. 130 feet to the beginning corner, and being the same plot of land conveyed to me by *J. M. Philipp* by his deed dated June 18, 1929 and recorded in the *S.D.C. Office* for Greenville County in *Deed Book 70 page 130*.
