SEND GREETING:

WHEREAS, I, F.C. Justus, the said, well and truly indebted to Mrs. H.H. Shuman, Executrix in and by my certain promissory note in writing, of even date with these presents, am in the full and just sum of Two thousand (\$2000.00) Dollars, to be paid one year after date

with interest thereon, from date annually at the rate of 8 per cent. per annum, to be computed and paid annually until paid in full, all interest not paid when due bear interest at the same rate as principal, and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of

ten per cent besides all costs and expenses of collection, to be added to the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage) as in and by the said note, reference being thereunto had, as will more fully appear.

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, I have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said Mrs. H.H. Shuman, Executrix. All that certain piece, parcel or lot of

land situate, lying and being in the County and State aforesaid, in Greenville Township, lying and being in what is known as Morgan Hill, on Parker Road (formerly Monaghan Road), and having the following metes and bounds, to-wit:
Beginning at a stake, corner of lot now or formerly owned by S.D. Olson, and running thence with her line S. 70-30 W. 154 feet to a stake; thence N. 7-1/4 W. 19 feet to a stake; thence S. 76-1/2 W. 45 feet to a stake; thence N. 6-45 W. 79.5 feet to a stake; thence N. 67-45 E. 145 feet to the Parker Road; thence with Parker Road S. 37 E. 112 feet to the beginning corner.
