TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, Sarah Goldstein of the County and State aforesaid, SEND GREETING:

WHEREAS, I, the said Sarah Goldstein, in and by my certain promissory note in writing, of even date with these presents, am well and truly indebted to Sarah Gluckman

in the full and just sum of Three Thousand and no/100 Dollars, to be paid One year from date

with interest thereon, from date at the rate of 6 per cent per annum, to be computed and paid semi-annually

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of ten per cent

besides all costs and expenses of collection, to be added to the amount due on said note; to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being thereunto, shall as will more fully appear.

NOW, KNOW ALL MEN, that the said Sarah Goldstein in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said Sarah Gluckman according to the terms of said note, and also in consideration of the further sum of Three Dollars, to me, the said Sarah Goldstein, in hand well and truly paid by the said Sarah Gluckman

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said Sarah Gluckman her heirs and assigns

forever, all that piece, parcel or lot of land, situate in the County and State aforesaid in the City of Greenville, on the corner of Hyde and Mayfield Streets and having the following metes and bounds, to-wit: Beginning at the corner of said Hyde and Mayfield Streets and running thence with Hyde Street S. 70-45 E. 40 feet to an iron pipe thence S. 19-45 W. 150 feet more or less to M^r. Alister's line thence with M^r. Alister's line N. 70-45 W. 40 feet to an iron pipe on Mayfield Street thence with Mayfield Street N. 19-45 E. 150 feet more or less to the beginning corner.
