WHEREAS, **I**, the said **H.G. Lindsey**
in and by **Two** certain **promissory** note **5** in writing, of

in the full and just sum of **four hundred twenty-five and no/100**
Dollars, to be paid **as therein stated**

with interest thereon from **date** at the rate of **eight** per cent. per annum, to be
computed and paid **annually**

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or
interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof,
who may sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of

ten per cent besides all costs and expenses of collection, to be
added to the amount due on said note to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or
any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note,
reference being thereunto had, as will more fully appear.

NOW, KNOW ALL MEN, That **I**, the said **H.G. Lindsey**
in consideration of the said debt and sum of money aforesaid, and for the better security of the payment thereof to the said

according to the terms of said note, and also in consideration of the further sum of Three Dollars, to **me**, the said

in hand well and truly paid by the said **J.O. Stokes**

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents, do grant,
bargain, sell and release unto the said **J.O. Stokes** all that lot of land situate in the County and State

aforesaid, near the Town of Greer, having the following metes and bounds: Beginning on the
Top-soil Road, at the corner of lot #15 and runs thence with said Road S. 1.00 W. 50 feet
to the corner of lot #17; thence along the line of this lot N. 89 W. 187 feet; thence N.
1.00 E. 50 feet to the corner of lot #15; thence along the line of this lot S. 89 E. 187
feet to the beginning corner, being designated as lot #16 on a subdivision of the O.P. Smith
property made by W.A. Christopher May 17th, 1924.

Also all that other lot of land situate as aforesaid adjoining the above described lot and
having the following described metes and bounds: Beginning on the said Top-soil Road at the
corner of lot #16 and runs thence with said road S. 1.00 W. 50 feet to an Avenue 30 feet
