SEND GREETING:

WHEREAS, I do hereby certify that Edward Howard

in and by myself certain promissory note in writing of even date with these presents and well and truly indebted to GREENVILLE BUILDING AND LOAN ASSOCIATION, a corporation, incorporated under the laws of the State of South Carolina, in the full and just sum of Four thousand

DOLLARS,

to be paid on or before the date when the 2-28 series of the Capital Stock of the said GREENVILLE BUILDING AND LOAN ASSOCIATION shall reach maturity, with interest thereon from date at the rate of eight per cent. per annum, payable weekly on or before Saturday night of each and every week until paid in full; and if I fail to pay said interest or to comply in all respects with the Constitution and by-laws of said Association, for the space of thirty days, then said debt shall become immediately due and payable, together with all interest, fines and expenses and all amounts advanced by the said Association on the within described property, by way of taxes or insurance, the same to be added to the amount due on said note and to be collectible as part thereof, together with an attorney's fee of ten per cent. if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof be collected by an attorney, or legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note reference being hereunto had, will more fully appear.

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said GREENVILLE BUILDING AND LOAN ASSOCIATION, according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to me the said Edward Howard in hand well and truly paid by the said GREENVILLE BUILDING AND LOAN ASSOCIATION at and before the signing of these presents, the receipt whereof is hereby acknowledged, have Granted, Bargained, Sold and Released and by these presents do Grant, Bargain, Sell and Release unto the said GREENVILLE BUILDING AND LOAN ASSOCIATION all that parcel or lot of land in

Greenville Township, Greenville County, State of South Carolina, situate, lying and being near the southern corporate limits of the city of Greenville, being lot No. 5 on Plat 4 of Park Hill property of Mrs. E. Lewis recorded in the R. M. C. office for Greenville County, in "Book 7" page 136, and being more particularly described as follows: to-wit: Beginning at a stake on the North side of Euseb Street, at corner of lot No. 5 and running thence with the line of that lot N. 27-10 E. 100 feet to a stake on line of lot No. 10, thence with the line of that lot N. 62-50 W. 90 feet to a stake corner of lot No. 11; thence with the line of that lot S. 27-10 W. 100 feet to a stake on Euseb Street; thence with said street as the line S. 62-50 E. 90 feet to the beginning corner.
