43rd. All that certain lot or parcel of land situate, lying and

being on the corner of Grove Road and Elm Street, in Greenville Township, County and State aforesaid, and being known and designated as Lot No. 19 in Block "M" of the O.P. Mills property as shown on plat recorded in the R.M.C. Office for Greenville County, in Plat Book "C", page 176, and having the following metes and bounds, to-wit: Beginning at an iron pin at northwest corner of Grove Road and Elm Street; thence along the east side of Elm Street around a curve to the right, the course and distance of chord being N. 58-26 W. 103.5 feet to an iron pin at point of tangency of side curve; thence continuing with said Street N. 44-33 W. 85 feet to an iron pin, corner lot No. 20; thence along south line of lot No. 20, N. 36-37 E. 60.3 feet to iron pin; thence along line of lot No. 18, S. 53-0 E. 167.2 feet to iron pin, North side of Grove Road; thence along the north side of Grove Road around a 11° 46' curve to the left, courses and distances of chord being S. 2-32 W. 15 feet to iron pin at point of tangency; thence continuing with North side of Grove Road S. 18-37 W. 51.5 feet to point of beginning.
