DOLLARS,

to be paid on or before the date when the 43rd. series of the Capital Stock of the said GREENVILLE BUILDING AND LOAN ASSOCIATION shall reach maturity, with interest thereon from date at the rate of eight per cent. per annum, payable weekly on or before Saturday night of each and every week until paid in full; and if I fail to pay said interest or to comply in all respects with the Constitution and By-Laws of said Association, for the space of thirty days, then said debt shall become immediately due and payable, together with all interest, fines and expenses, and all amounts advanced by the said Association on the within described property, by way of taxes or insurance, the same to be added to the amount due on said note and to be collectible as part thereof, together with an attorney's fee of ten per cent. if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof be collected by an attorney, or legal proceedings of any kind (of which is secured under this mortgage); as in and by the said note, reference being hereunto had, will more fully appear.

lying and being in Greenville Township, Greenville County, State of South Carolina, on the Northwest corner of the intersection of Byrd Boulevard and Woodvale Avenue, and being known and designated as Lot No. 170 of the Trayler Park property of Realty Corporation and having according to a survey thereof prepared by C.M. Furman, Jr., Engineer on March 7th, 1925 the following metes and bounds, to-wit:-
Beginning at an iron pin, the northwest corner of the intersection of Byrd Boulevard and Woodvale Avenue, and running thence with the North side of Byrd Boulevard N. 60° 28' W. 70 feet to an iron pin, corner of lot No. 169; thence with the line of said lot N. 29° 32' E. 213.8 feet to an iron pin in line of lot No. 226; thence with the line of that lot S. 42° 53' E. 95.5 feet to an iron pin on Woodvale Avenue; thence in a Southwesterly direction with Woodvale Avenue a curve line, the chord of which is 85 feet to an iron pin; thence still with said Woodvale Avenue S. 28° 30' W. 103.5 feet to the beginning corner.
