in the full and just sum of Eight hundred and no/100
(\$800.00) DOLLARS,

land situate, lying and being on the north side of Bull's Alley, in the City and County of Greenville, State of South Carolina, and having the following metes and bounds, to wit:
Beginning on the north side of said Bull's Alley, at the rear corner of the lot of J. W. Harrison, and running thence in a northerly direction along the line of that and other lots 70 ft. to a point; thence in a line parallel with said Bull's Alley in an easterly direction 35 ft.; thence in a straight line to said Alley 70 ft. to a point which point is 35 ft. from the beginning corner; thence in a westerly direction along said Bull's Alley 35 ft. to the beginning corner.
