fore Saturday night of each and every week until paid in full; and if I fail to pay said interest or

is hereby acknowledged, have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said GREENVILLE
BUILDING AND LOAN ASSOCIATION all that certain lot situated on

parcel of land situate lying and being in the State of South Carolina and County of Greenville in the First Ward of the City of Greenville in the following mets and bounds according to a survey made during the present term by R. E. Dalton Surveyor to wit:
