SEND GREETING:

WHEREAS, *we*, the said *H. P. Brissey and Annie May Brissey*

in and by *Our* certain promissory note in writing of even date with these presents *are* well and truly indebted to GREENVILLE BUILDING AND LOAN ASSOCIATION, a corporation, incorporated under the laws of the State of South Carolina, in the full and just sum of *Fifteen Hundred (\$1,500.00)*

DOLLARS,

to be paid on or before the date when the *151B* series of the Capital Stock of the said GREENVILLE BUILDING AND LOAN ASSOCIATION shall reach maturity, with interest thereon from date at the rate of eight per cent. per annum, payable weekly on or before Saturday night of each and every week until paid in full; and if *we* fail to pay said interest or to comply in all respects with the Constitution and By-Laws of said Association, for the space of thirty days, then said debt shall become immediately due and payable, together with all interest, fines and expenses, and all amounts advanced by the said Association on the within described property, by way of taxes or insurance, the same to be added to the amount due on said note and to be collectible as part thereof, together with an attorney's fee of ten per cent. if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof be collected by an attorney, or legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being hereunto had, will more fully appear.

NOW, KNOW ALL MEN, That *H. P. Brissey and Annie May Brissey*, the said *H. P. Brissey and Annie May Brissey*

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said GREENVILLE BUILDING AND LOAN ASSOCIATION, according to the terms of the said note, and also in consideration of the further sum of *Three Dollars*, to *us* the said *H. P. Brissey and Annie May Brissey* in hand well and truly paid by the said GREENVILLE BUILDING AND LOAN ASSOCIATION at and before the signing of these presents, the receipt whereof is hereby acknowledged, have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said GREENVILLE BUILDING AND LOAN ASSOCIATION

All that certain piece, parcel or lot of land situate lying and being near the city of Greenville, County and State aforesaid on the North side of Catechee Road and known and designated as Lot No. 77 on Plat of Cherokee Park, which Plat is recorded in the S.R. M.C. Office for Greenville County in Plat Book "C" at Page 96, and having, according to said Plat the following metes and bounds to-wit:
Beginning at an iron Pin on the North side of Catechee Road at the joint corner of Lots Nos. 77 and 78 and running thence with the Northern side of said Catechee Road, S. 71-45 W. 60 feet to an iron Pin joint corner of Lots Nos. 76 and 77; thence with the joint line of said Lots N. 14-15 W. 186 feet to an iron Pin near joint corner of last mentioned lots; thence N. 75-45 E. 60 feet to an iron Pin near joint corner of Lots Nos. 77 and 78; thence with the joint line of said lots, S. 14-15 E. 182 feet to the point of beginning.
