WHEREAS, *L. L. McCrary*, the said

to be paid on or before the date when the series of the Instalment Stock of the said THE PEOPLES BUILDING AND LOAN ASSOCIATION shall reach maturity, with interest thereon from date at the rate of eight per cent. per annum, payable

Beginning at a stake on the eastside of Chandler Street, on the northwest corner of lot No. 102, on said plat, said stake being 100 feet northward from northeast corner of Chandler and Martin Streets, running thence N. 89-1/2 E. 148 feet along line of lot No. 102 to a stake on a ten foot alley; thence along Westside of said alley N. 11-1/2 W. 50 feet to a stake on southeast corner of lot No. 100; thence with line of lot No. 100, S. 89-1/2 W. 148 feet to a stake on Chandler Street; thence with said Street S. 11-1/2 E. 50 feet to point of beginning.
