TO HAVE AND TO HOLD, all and singular the said Premises unto the said THE PEOPLES BUILDING AND LOAN ASSOCIATION, and its successors and assigns forever. And *I* do hereby bind *myself my me and my* Heirs, Executors and Administrators to warrant and forever defend all and singular the said Premises unto the said THE PEOPLES BUILDING AND LOAN ASSOCIATION, and its successor and assigns, from and against.

And *I* agree to insure the house and building on said lot in a sum not less than *Three Thousand* Dollars in a company or companies satisfactory to the mortgagee and keep the same insured from loss or damage by fire, and assign the policy of insurance to the said mortgagee; and in the event that *I* shall at any time fail to do so then the said mortgagee may cause the same to be insured in its name and reimburse itself for the premium and expense of such insurance with interest under this mortgage.
