SEND GREETING:

WHEREAS, *she*, the said *Mrs. L. J. McKinney*

in and by *my* certain promissory note in writing, of even date with these presents *and* well and truly indebted to THE PEOPLES BUILDING AND LOAN ASSOCIATION, a corporation incorporated under the laws of the State of South Carolina, in the full and just sum of

Thirty three hundred (\$3300.00)

DOLLARS,

to be paid on or before the date when the *7th* Series of the Instalment Stock of the said THE PEOPLES BUILDING AND LOAN ASSOCIATION shall reach maturity, with interest thereon from date at the rate of eight per cent. per annum, payable

Being known and designated as part of lots no. 13 and 14 of property known as Lane Luce's Villa, see plat book "A" at page 510 in the office of the R.M.C. for Greenville County, said lot having a frontage on Broadman Avenue of 50 feet and measuring 175 feet to a lot fronting on Young Street. Beginning at a point 56.21 feet from (the south) side of Young Street, corner of Dixie Coggins running thence with Broadman Avenue S. 10.30 W. 50 feet, thence running about N. 57.35 W. 175 feet to line of lot fronting on Young Street, now or formerly of L. J. McKinney, thence with line of last mentioned lot 50 feet, more or less to lot of Dixie Coggins, thence with line of lot of Dixie Coggins 175 feet to the point of beginning.
