WHEREAS, I, the said C. S. Chaudler

in and by my certain promissory note in writing, of even date with these presents well and truly indebted to THE PEOPLES BUILDING AND LOAN ASSOCIATION, a corporation incorporated under the laws of the State of South Carolina, in the full and just sum of

Twelve hundred \$1200.00

DOLLARS,

to be paid on or before the date when the 8th Series of the Instalment Stock of the said THE PEOPLES BUILDING AND LOAN ASSOCIATION shall reach maturity, with interest thereon from date at the rate of eight per cent. per annum, payable

Beginning at a stake on the north side of Wilbanks street 164.2 feet from White Horse Road, running thence S. 75.00 W. 200 feet to a stake in line with lot No. 33; thence with line of said lot S. 79.45 W. 50 feet to an iron pin, corner lot No. 34; thence with line of said lot S. 15.00 E. 200 feet to an iron pin on Wilbanks street; thence with said Wilbanks street, N. 79.45 E. 50 feet to the point of beginning.
