All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, and in the City of Greenville, and known and designated as Lot Number Seventeen of Block "B" of Cagle Park, according to a map or plat of said Cagle Park of record in Plat Book "C" at page 238 in the office of the R.M.C. for Greenville County, State aforesaid, said lot of land having the following metes and bounds, to-wit Beginning at an iron pin on the North side of Mills Avenue, corner of Lot 18; thence with the line of Lot 18, North 38 deg. West two hundred twenty-six and 3/10 feet to an iron pin in the line of Lot No. 28; thence with the line of Lots Nos. 28 and 29 in a Westerly direction sixty-three and 7/10 feet to an iron pin, corner of lot No. 16; thence with line of Lot No. 16 South 1 deg. 4 min.
