TO ALL WHOM THESE PRESENTS MAY CONCERN:

That I, Jessie Craig  
of Greenville, in the County of Greenville, and the State of South Carolina, send Greeting:

WHEREAS, I, the said Jessie Craig  
in and by my certain note or obligation, bearing the 16th day of May 1924  
am indebted unto The Carolina Loan and Trust Company, of the City and County of Greenville, in said State (a body corporate,  
duly incorporated under the laws of such State), in the sum of Three Thousands & <sup>no</sup>/<sub>100</sub> (\$3000.00) Dollars,  
with interest thereon at the rate of eight per centum per annum, payable monthly, from the 16th day of May A. D. 1924,  
according to the provisions of the Charter, By-Laws, Rules and Regulations of the said Company, in manner and form following, that is to say, that

I the said Jessie Craig shall pay or cause to be paid to the said  
Company, or its certain attorneys, successors or assigns, at Greenville City aforesaid, monthly, on the 20th or before the end of the month of May  
1924, and on the 20th or before the end of each month thereafter for twenty successive months, the sum of

Dollars, being the monthly interest on the advance or loan) until there have been paid twenty monthly payments, and shall for the next twenty months pay the  
sum of Forty-six & <sup>no</sup>/<sub>100</sub> (\$46.00) Dollars, (\$30.00) Dollars, being the regular monthly payment on said stock and Sixteen & <sup>no</sup>/<sub>100</sub> (\$16.00) Dollars, being the monthly interest on balance due);

for the next twenty months the sum of Forty-two & <sup>no</sup>/<sub>100</sub> (\$42.00) Dollars, (\$30.00) Dollars, being the regular monthly payment on said stock and Twelve & <sup>no</sup>/<sub>100</sub> (\$12.00)

Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of Thirty-eight & <sup>no</sup>/<sub>100</sub> (\$38.00)

Dollars, (\$30.00) Dollars, being the regular monthly payment on said stock and Eight & <sup>no</sup>/<sub>100</sub> (\$8.00) Dollars, being the monthly payment on said shares of stock and

the sum of Thirty-four & <sup>no</sup>/<sub>100</sub> (\$34.00) Dollars, (\$30.00) Dollars, being the monthly interest on balance due); for the next twenty months pay the  
monthly payment on said shares of stock and Four & <sup>no</sup>/<sub>100</sub> (\$4.00) Dollars, being the monthly interest on balance due.)

said note or obligation, and the condition thereunder written reference being thereunto had will more fully appear.

NOW, KNOW Me, That I the said Jessie Craig  
in consideration of the said debt and sum of money as aforesaid, and for the better securing the payment thereof to the said The Carolina Loan and Trust Company,  
according to the terms of said note or obligation, and also in consideration of the further sum of Five Dollars to me

In the City of Greenville, on East Avenue known and designated as Lot No. 20, as per  
plat of Malcolm and Elizabeth Jones property, recorded in the Office of R.M.C. for  
County and State aforesaid in Plat Book "E", pages 37 and 38, and having a frontage of  
Sixty-four (64) feet on South side of said East Avenue and running back in parallel lines  
West line being One hundred ninety-four (194) feet and the Eastern line One hundred  
ninety and <sup>5</sup>/<sub>10</sub> (190.5) feet, and adjoining property now or formerly owned by Mark-  
Osborn on the East and that of Mrs. Steel on the West, and being the same lot of land
