That I, J. E. Poole
of Greenville, in the County of Greenville, and the State of South Carolina, send Greeting:
WHEREAS, I, the said J. E. Poole
in and by my certain note or obligation, bearing the 18th day of August 1924
am indebted unto The Carolina Loan and Trust Company, of the City and County of Greenville, in said State (a body corporate,
duly incorporated under the laws of such State), in the sum of Two hundred + 7/100 (\$200.00) Dollars,
with interest thereon at the rate of eight per centum per annum, payable monthly, from the 18th day of August, A. D. 1924,

Dollars, being the monthly interest on the advance or loan) until there have been paid ten monthly payments, and shall for the next ten
sum of Five + 0/100 (\$5.00) Dollars, (\$4.00) Dollars, being the regular monthly payment on said stock and One + 0/100 (\$1.00)
Dollars, being the monthly interest on balance due); for the next ten months the sum of Four + 80/100 (\$4.80) Dollars, (\$4.00) Dollars,
being the regular monthly payment on said stock and Eighty cents (\$0.80)
Dollars, being the monthly interest on balance due); for the next ten months pay the sum of Four + 53/100 (\$4.53)
Dollars, (\$4.00) Dollars, being the monthly payment on said shares of stock and
Fifty - Three cents (\$0.53) Dollars, being the monthly interest on balance due); for the next ten
sum of Four + 27/100 (\$4.27) Dollars, (\$4.00) Dollars, being the
monthly payment on said shares of stock and Twenty - seven cents (\$0.27) Dollars, being the monthly interest on balance due.)

NOW, KNOW ALL MEN, That I the said J. E. Poole
in consideration of the said debt and sum of money as aforesaid, and for the better securing the payment thereof to the said The Carolina Loan and Trust Company,
according to the terms of said note or obligation, and also in consideration of the further sum of Five Dollars to me

in hand well and truly paid by the said The Carolina Loan and Trust Company, at and before the sealing and delivery of these Presents, (the receipt whereof is
hereby acknowledged), have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said The Carolina Loan and
Trust Company, all that tract or parcel of land, situated in the County of Greenville, State of South Carolina, and described as follows:

In City of West Greenville, Beginning on Southwest corner
on Pendleton and Aiken Streets, thence with Pendleton
Street N. 69-22 W. 52.7 feet to Garrett's corner; thence with
Garrett's line S. 44-30 W 60.8 feet to corner of lot no. 2;
thence with line of lot no. 2, S. 46-07 E. 49.1 feet to
Aiken Street; thence with Aiken Street N. 43-53 E. 81.6
feet to the beginning corner, being lot no. 1 of L. K. Kelly
land, plat recorded in Plat Book "F," Page 38, and
is the same lot conveyed to me by Lilly A. Kelly, et al,
by deed date February 21st, 1922, and recorded in
