

THE STATE OF SOUTH CAROLINA,

TO ALL WHOM THESE PRESENTS MAY CONCERN:

That I, C.M. Harling, of Greenville, in the County of Greenville, and the State of South Carolina, send Greeting:

WHEREAS, I, C.M. Harling, in and by my certain note or obligation, bearing the 23rd day of October 1924

I am indebted unto The Carolina Loan and Trust Company, of the City and County of Greenville, in said State (a body corporate, duly incorporated under the laws of such State), in the sum of Thirty-five hundred (\$3500.00) Dollars, with interest thereon at the rate of eight per centum per annum, payable monthly, from the 23rd day of October A. D. 1924, according to the provisions of the Charter, By-Laws, Rules and Regulations of the said Company, in manner and form following, that is to say, that

I, C.M. Harling, shall pay or cause to be paid to the said Company, or its certain attorneys, successors or assigns, at Greenville City aforesaid, monthly, on the 20th or before the end of the month of Nov. 1924, and on the 20th or before the end of each month thereafter for twenty successive months, the sum of

Fifty eight & 33/100 (\$58.33) Dollars, (\$35.00 Dollars, being the regular monthly installment payable on the thirty-five (35) Shares of Stock, and twenty-three & no/100 (\$23.00) Dollars, being the monthly interest on the advance or loan) until there have been paid twenty monthly payments, and shall for the next twenty months pay the sum of

Fifty-three & 67/100 (\$53.67) Dollars, (\$35.00 Dollars, being the regular monthly payment on said stock and Eighteen & 67/100 (\$18.67) Dollars, being the monthly interest on balance due); for the next twenty months the sum of

Forty-nine & no/100 (\$49.00) Dollars, (\$35.00 Dollars, being the regular monthly payment on said stock and Fourteen & no/100 Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of

Forty-four & 33/100 (\$44.33) Dollars, (\$35.00 Dollars, being the monthly payment on said shares of stock and

Nine & 33/100 (\$9.33) Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of

Thirty-nine & 67/100 (\$39.67) Dollars, (\$35.00 Dollars, being the monthly payment on said shares of stock and four & 67/100 (\$4.67) Dollars, being the monthly interest on balance due.)

Each of the above payments to be made on the 20th or before the last day of each month, and shall thereafter surrender to the Company the said 35 shares of stock and the certificate thereof, the amount at such time paid shares by me to be credited as a payment upon the advance or loan made I, the said C.M. Harling,

and shall pay or cause to be paid all fines which may be duly imposed upon or charged against I, the said C.M. Harling,

in accordance with the Charter, By-Laws, Rules and Regulations, as in and by the said note or obligation, and the condition thereunder written, reference being thereunto had will more fully appear.

NOW, KNOW ALL MEN, That I, C.M. Harling, in consideration of the said debt and sum of money as aforesaid, and for the better securing the payment thereof to the said The Carolina Loan and Trust Company, according to the terms of said note or obligation, and also in consideration of the further sum of Five Dollars to

in hand well and truly paid by the said The Carolina Loan and Trust Company, at and before the sealing and delivery of these Presents, (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said The Carolina Loan and Trust Company, all that tract or parcel of land, situated in the County of Greenville, State of South Carolina, and described as follows:

In Greenville Township, being Lot No. 26 of Block F, of Kenatenah, plat recorded in Plat Book F, page 131, R.M.C. Office and described as follows:- Beginning on South side of Blessingame Street and runs thence with the Street N. 64-47 E. 60 feet to corner lot 27; thence S. 25-51 with line of lot No. 27, 160 feet to corner of lot 13; thence S. 63-35 W. 60 feet to the beginning corner, and being the same lot conveyed to me by B.H.-Peace, by deed dated September 16th, 1924, recorded in Volume 77, page 138, R.M.C. Office for Greenville County.
