TO ALL WHOM THESE PRESENTS MAY CONCERN:

That I, *Susannah Jane Lasswell* of Greenville, in the County of Greenville, and the State of South Carolina, send greeting:

WHEREAS, I, the said *Susannah Jane Lasswell*, in and by *my* certain note or obligation, bearing the *17th* day of *November* 192*4*

I am indebted unto The Carolina Loan and Trust Company, of the City and County of Greenville, in said State (a body corporate, duly incorporated under the laws of such State), in the sum of *Seven Hundred Fifty & no/100 (\$750.00)* Dollars, with interest thereon at the rate of eight per centum per annum, payable monthly, from the *18th* day of *November* A. D. 192*4*, according to the provisions of the Charter, By-Laws, Rules and Regulations of the said Company, in manner and form following, that is to say, that:

I, the said *Susannah Jane Lasswell*, shall pay or cause to be paid to the said Company, or its certain attorneys, successors or assigns, at Greenville City aforesaid, monthly, on the 20th or before the end of the month of *December* 192*4*, and on the 20th or before the end of each month thereafter for twenty successive months, the sum of

Twelve & 3/4 Cents (\$12.75) Dollars, (*12.75*) Dollars, being the regular monthly installment payable on the *7 1/2* Shares of Stock, and *Five & no/100 (\$5.00)* Dollars, being the monthly interest on the advance (or loan) until there have been paid twenty monthly payments, and shall for the next twenty months pay the

sum of *Seven & no/100 (\$7.00)* Dollars, (*7.50*) Dollars, being the regular monthly payment on said stock and *Four & no/100 (\$4.00)* Dollars, being the monthly interest on balance due); for the next twenty months the sum of

Five & no/100 (\$5.00) Dollars, (*10.50*) Dollars, being the regular monthly payment on said stock and *Three & no/100 (\$3.00)* Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of

Two & no/100 (\$2.00) Dollars, (*9.50*) Dollars, being the monthly payment on said shares of stock and *Eight & 5/100 (\$8.50)* Dollars, (*7.50*) Dollars, being the monthly interest on balance due); for the next twenty months pay the

sum of *One & no/100 (\$1.00)* Dollars, (*1.00*) Dollars, being the monthly interest on balance due.) Each of the above payments to be made on the 20th or before the last day of each month, and shall thereafter surrender to the Company the said

NOW, KNOW ALL MEN, That I, the said *Susannah Jane Lasswell*, in consideration of the said debt and sum of money as aforesaid, and for the better securing the payment thereof to the said The Carolina Loan and Trust Company, according to the terms of said note or obligation, and also in consideration of the further sum of *Five* Dollars to

the said *Susannah Jane Lasswell*, in hand well and truly paid by the said The Carolina Loan and Trust Company, at and before the sealing and delivery of these Presents, (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said The Carolina Loan and Trust Company, all that tract or parcel of land, situated in the County of Greenville, State of South Carolina, and described as follows:

Being a part of "Riverside" said lot being known and designated on a plat of said lands made by Carter & Mingle Surveyors, which plat is of record in said R. M. C. Office for Greenville County as Lot No. Seven (7) of Block "A.C." fronting Fifty (50) feet on Chicago Avenue and running back to a depth of One Hundred twenty (120) feet and eighty (8) inches, and being the same lot conveyed to me by Riverside Land Company, by its deed dated March 13th, 1924, and recorded in Volume *32* Page *158* R.
