Twelve & no/100 (\$12.50) Dollars, (*7.50*) Dollars, being the regular monthly installment payable on the *Seven and no/100 (\$7.00)* Shares of Stock, and *Five & no/100 (\$5.00)* Dollars, being the monthly interest on the advance or loan) until there have been paid twenty monthly payments, and shall for the next twenty months pay the sum of

Eleven & no/100 (\$11.50) Dollars, (*7.50*) Dollars, being the regular monthly payment on said stock and *Four & no/100 (\$4.00)* Dollars, being the monthly interest on balance due); for the next twenty months the sum of

Seven & no/100 (\$7.00) Dollars, (*7.50*) Dollars, being the regular monthly payment on said stock and *Three & no/100 (\$3.00)* Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of
