TO ALL WHOM THESE PRESENTS MAY CONCERN:

*Mr. Fred Tabor and Rosa Tabor*  
of Greenville, in the County of Greenville, and the State of South Carolina, send Greeting:  
WHEREAS, *we*, the said *Fred Tabor and Rosa Tabor*  
in and by *my* certain note or obligation, bearing the *20th* day of *June* 192*5*.  
indebted unto The Carolina Loan and Trust Company, of the City and County of Greenville, in said State (a body corporate,  
duly incorporated under the laws of such State), in the sum of *One Thousand (\$1000.00)* Dollars,  
with interest thereon at the rate of eight per centum per annum, payable monthly, from the *20th* day of *June* A. D. 192*5*,  
according to the provisions of the Charter, By-Laws, Rules and Regulations of the said Company, in manner and form following, that is to say, that  
*we* the said *Rosa Tabor and Fred Tabor* shall pay or cause to be paid to the said  
Company, or its certain attorneys, successors or assigns, at Greenville City aforesaid, monthly, on the 20th or before the end of the month of *July*  
192*5*, and on the 20th or before the end of each month thereafter for twenty successive months, the sum of *Sixteen and 66/100 (\$16.66)* Dollars, (*\$10.00*) Dollars,  
being the regular monthly installment payable on the *10* Shares of Stock, and *\$6.66*  
Dollars, being the monthly interest on the advance or loan) until there have been paid twenty monthly payments, and shall for the next twenty months pay the  
sum of *Fifteen and 33/100 (\$15.33)* Dollars, (*\$10.00*) Dollars, being the regular monthly payment on said stock and *\$5.33* Dollars, being the monthly interest on balance due);  
for the next twenty months the sum of *Fourteen and 33/100 (\$14.00)* Dollars, (*\$10.00*) Dollars, being the regular monthly payment on said stock and *\$4.00*  
Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of *Twelve and 67/100 (\$12.67)*  
Dollars, (*\$10.00*) Dollars, being the monthly payment on said shares of stock and *\$2.67* Dollars, being the monthly interest on balance due); for the next twenty months pay the  
sum of *Eleven and 33/100 (\$11.33)* Dollars, (*\$10.00*) Dollars, being the monthly payment on said shares of stock and *\$1.33* Dollars, being the monthly interest on balance due.)  
Each of the above payments to be made on the 20th or before the last day of each month, and shall thereafter surrender to the Company the said *10*  
shares of stock and the certificate therefor, the amount of such three paid shares by *me* to be credited as a payment upon the advance or loan made. *we* the said *Fred Tabor and*  
*Rosa Tabor* and shall pay or cause to be paid all fines which may be duly imposed upon or charged against *me* the said *Fred Tabor and*  
*Rosa Tabor* in accordance with the Charter, By-Laws, Rules and Regulations, as in and by the  
said note or obligation, and the conditions hereunder written, reference being thereunto had will more fully appear.  
NOW, KNOW ALL MEN, That *we* the said *Fred Tabor and Rosa Tabor*  
in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said The Carolina Loan and Trust Company,  
according to the terms of said note or obligation, and also in consideration of the further sum of Five Dollars to *us*  
the said *Fred Tabor and Rosa Tabor*  
in hand well and lawfully paid by the said The Carolina Loan and Trust Company, at and before the sealing and delivery of these Presents, (the receipt whereof is  
hereby acknowledged), have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said The Carolina Loan and  
Trust Company, all that tract or parcel of land, situated in the County of Greenville, State of South Carolina, and described as follows:

*Being Lot No. Forty-Two (42) of Sans Souci Park, a sub-  
division of lands represented by a plat recorded in  
Plat Book C, page 158. Said lot begins on the East  
side of Davis Street at corner of Lot No. 43; thence S.  
55-54 E. One Hundred forty five (145) feet to right-of-  
way of P. & N. Railway; thence with right-of-way of  
P. & N. Railway South 56 feet to corner of Lot # 41; thence  
N. 55-54 W. One hundred fifty-six (156) feet to Davis  
Street. thence with Davis Street N. 30-18 E. fifty-feet  
to the beginning corner. And being the same lot of  
land conveyed to me by Traylor Real Estate Com-  
pany by deed dated August 10th. 1923, and record-
