TO ALL WHOM THESE PRESENTS MAY CONCERN:

I Amelia C. Potts
of Greenville, in the County of Greenville, and the State of South Carolina, send Greeting:
WHEREAS, I, Amelia C. Potts, the said Amelia C. Potts
in and by her certain note or obligation, bearing the date twenty second day of July 1925
indebted unto The Carolina Loan and Trust Company, of the City and County of Greenville, in said State (a body corporate,
duly incorporated under the laws of such State), in the sum of Five Hundred & No/100 (\$2,00.00) Dollars,
with interest thereon at the rate of eight per centum per annum, payable monthly, from the 20th day of August A. D. 1925,
according to the provisions of the Charter, By-Laws, Rules and Regulations of the said Company, in manner and form following, that is to say, that I
the said Amelia C. Potts shall pay or cause to be paid to the said
Company, or its certain attorneys, successors or assigns, at Greenville City aforesaid, monthly, on the 20th or before the end of the month of August
1925, and on the 20th or before the end of each month thereafter for ten successive months, the sum of Five & 33/100 (\$5.33)
Dollars, (Four & No/100 Dollars,
being the regular monthly installment payable on the Five Shares of Stock, and one & 33/100 (\$1.33)
Dollars, being the monthly interest on the advance or loan) until there have been paid ten monthly payments, and shall for the next ten months pay the
sum of Five & 07/100 (\$5.07) Dollars, (Four (\$4.00)
Dollars, being the regular monthly payment on said stock and one & 07/100 (\$1.07) Dollars, being the monthly interest on balance due);
for the next ten months the sum of Four & 80/100 (\$4.80) Dollars,
(Four (\$4.00) Dollars, being the regular monthly payment on said stock and Eighty cents
Dollars, being the monthly interest on balance due); for the next ten months pay the sum of Four & 53/100 (\$4.53)
Dollars, (Four Dollars, being the monthly payment on said shares of stock and
Fifty three cents (.53) Dollars, being the monthly interest on balance due); for the next ten months pay the
sum of Four & 27/100 (\$4.27) Dollars, (Four (\$4.00) Dollars, being the
monthly payment on said shares of stock and Twenty seven cents (.27) Dollars, being the monthly interest on balance due.)
Each of the above payments to be made on the 20th or before the last day of each month, and shall thereafter surrender to the Company the said Two
shares of stock and the certificate thereof, the amount of such two shares by me to be credited as a payment upon the advance or loan made. I, the said
Amelia C. Potts,
and shall pay or cause to be paid all fees which may be duly imposed upon or charged against I the said Amelia C. Potts
in accordance with the Charter, By-Laws, Rules and Regulations, as in and by the
said note or obligation, and the condition thereof, reference being thereunto had will more fully appear.
NOW KNOW ALL MEN, That I, the said Amelia C. Potts
in consideration of the said debt and sum of money as aforesaid, and for the better securing the payment thereof to the said The Carolina Loan and Trust Company,
according to the terms of said note or obligation, and also in consideration of the further sum of Five Dollars to me
the said Amelia C. Potts
in hand well and truly paid by the said The Carolina Loan and Trust Company, at and before the sealing and delivery of these Presents, (the receipt whereof is
hereby acknowledged), have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said The Carolina Loan and
Trust Company, all that tract or parcel of land, situated in the County of Greenville, State of South Carolina, and described as follows:

In Greenville Township about two and one-half miles
North of the City of Greenville in a section known as
Law Street lying on the West side of Gridley
Street Mountain View Land Company property
as shown by plat made by W. A. Adams and
recorded in R. M. C. Office for Greenville County
plat Book A. pages 396 and 397 and having the
following meter and bounds to wit:- Beginning at
a pin on the west side of Gridley Street, joint
corner with lot No. 41 and running thence with
joint line of Lot No. 41. N. 89 1/2° E. 146 feet to pin on a
ten foot alley; thence with said alley N. 11 1/2° E. 50
feet to a pin joint corner with lot No. 42, thence
along joint line of Lot No. 43. S. 89 1/2° E. 144 feet to a pin
on Gridley Street; thence along said Gridley Street S.
13 E. 50 feet to the beginning corner, being lot No. 42 of
Block as shown by plat recorded in plat book A.
