

THE STATE OF SOUTH CAROLINA,

TO ALL WHOM THESE PRESENTS MAY CONCERN:

That I, W. S. Ray  
of Greenville, in the County of Greenville, and the State of South Carolina, send Greeting  
WHEREAS, I, the said W. S. Ray  
in and by W. S. Ray certain note or obligation, bearing the 5th day of January 1925  
1000 indebted unto The Carolina Loan and Trust Company, of the City and County of Greenville, in said State (a body corporate,  
duly incorporated under the laws of such State), in the sum of Five Hundred and no/100 (\$600.00) Dollars,  
with interest thereon at the rate of eight per centum per annum, payable monthly, from the 5th day of January A. D. 1925,  
according to the provisions of the Charter, By-Laws, Rules and Regulations of the said Company, in manner and form following, that is to say, that  
the said W. S. Ray shall pay or cause to be paid to the said  
Company, or its certain attorneys, successors or assigns, at Greenville City aforesaid, monthly, on the 20th or before the end of the month of January  
1926, and on the 20th or before the end of each month thereafter for twenty successive months, the sum of 40.00  
Dollars, 6.00 Dollars,  
being the regular monthly installment payable on the 100 Shares of Stock, and 40.00  
Dollars, being the monthly interest on the advance or loan until there have been paid twenty monthly payments, and shall for the next twenty months pay the  
sum of 4.20 Dollars, 6.00  
Dollars, being the regular monthly payment on said stock and 3.20 Dollars, being the monthly interest on balance due);  
for the next twenty months the sum of 8.40 Dollars, being the regular monthly payment on said stock and 2.50  
Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of 1.60  
Dollars, 6.00 Dollars, being the monthly payment on said shares of stock and  
1.60 Dollars, being the monthly interest on balance due); for the next twenty months pay the  
sum of 6.80 Dollars, 6.00 Dollars, being the monthly payment on said shares of stock and  
0.80 Dollars, being the monthly interest on balance due.)  
Each of the above payments to be made on the 20th or before the last day of each month, and shall thereat surrender to the Company the said six  
shares of stock and the certificate thereof, the amount at such time paid shares by me to be credited as a payment upon the advance or loan made, the said  
W. S. Ray and shall pay or cause to be paid all fines which may be duly imposed upon or charged against the said W. S. Ray  
said note or obligation, and the condition thereunder written, reference being thereunto had with more fully appear.  
NOW, KNOW ALL MEN, That I, the said W. S. Ray  
in consideration of the said debt and sum of money as aforesaid, and for the better securing the payment thereof to the said The Carolina Loan and Trust Company,  
according to the terms of said note or obligation, and also in consideration of the further sum of Five Dollars to me  
the said W. S. Ray  
in hand well and truly paid by the said The Carolina Loan and Trust Company, at and before the sealing and delivery of these Presents, (the receipt whereof is  
hereby acknowledged), have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said The Carolina Loan and  
Trust Company, all that tract or parcel of land, situated in the County of Greenville, State of South Carolina, and described as follows:

About two and one-half miles West of Greenville Court House, North of Cedar Lane Road,  
or Main Street on West side of River Street, containing One (1) acre, more or less, and  
having the following metes and bounds, to-wit:- Beginning at an iron pin 3x, 208  
feet from Cedar Lane Road or Main Street on West side of River Street and running  
thence with said Street 9-3/4 E. 208 feet to an iron pin or stone 3x; thence N.  
80-1/4 W. 210 feet with South side of Center Street to an iron pin or stone 3x; thence  
S. 9-3/4 W. 208 feet to an iron pin or stone 3x, on middle line; thence S. 80-1/4 E.  
with said line or Springfield's line, 210 feet to the beginning corner, being lot 18  
and 19 of Map B. of the Finlay lands, and being the same lot of land conveyed to me by
