

or connected with and in and upon all of the aforementioned lands and buildings thereon, it being hereby specifically represented as a part of the consideration moving to the acceptance of this mortgage that the above described premises are free from the lien of all incumbrances, except as hereinabove indicated. To have and to hold all and singular the above described property, together with the buildings and improvements on said lands, and the rights, privileges, advantages and appurtenances thereunto belonging or in any wise appertaining, unto the said mortgagee, his heirs, personal representatives and assigns forever. But in trust, nevertheless, for the equal pro-rata benefit and security of all and every holder of the promissory notes and interest coupon notes issued under and secured by this mortgage, in accordance with the terms hereof

and for the enforcement of the payment thereof, when payable, in accordance with the true intent and meaning and stipulations hereof, of said notes and interest coupons respectively, and without preference as to lien or otherwise of any one note over any other note, so that each note issued under this mortgage shall have the same right, lien and privilege hereunder, so that the principal and interest of every note shall be equally secured hereby according to the amount of principal and interest of each note respectively. And the said mortgagor binds himself, his heirs, personal representatives and assigns to warrant and forever defend all and singular the said premises unto the said mortgagee, his heirs, personal representatives and assigns forever, from and against himself, his heirs, personal representatives and assigns, and every person whosoever lawfully claiming or to claim the same, or any part thereof.

Only such notes as shall be certified by Volting First Mortgage Corporation mortgagee, by the signing of the certificate endorsed thereon shall be secured by this mortgage, or be entitled to any benefit or lien hereunder, and such certificate of Volting First Mortgage Corporation mortgagee, shall be conclusive evidence that the notes so certified have been duly issued hereunder and are entitled to the benefit of the trust hereby created.

And it is hereby covenanted and agreed between the parties hereto, representing themselves, their heirs, personal representatives and assigns as follows, to-wit:
