 It now Therefore, in consideration of said extension, the said party of the first part does hereby agree with the said party of the second part to pay interest on said note as hereby extended from the 1st. day of April A. D. 1928 until said principal shall be fully paid at the rate of Six per cent per annum, payable semi-annually on the 1st. days of October and April and in each year;
 and the said party of the first part further agrees at the option of the party of the second part, to pay the said principal note as hereby extended, in manner and form and at the place as provided in the said original note.

It is hereby further agreed, That all the stipulations and provisions of the said principal note and all the covenants and conditions of the mortgage deed given to secure the same, shall remain in full force and effect, except only as expressly modified herein. It is agreed, That the Statute of Limitations shall not begin to run against the said mortgage or note until after the end of said extended period.
