O. Allen; thence with line of lot now or formerly owned by C. O. Allen S. 64 1/2 E. 50 feet to an iron pin; thence approximately S. 28 N. 90 feet more or less, to an iron pin on Arlington Ave. which pin is 50 feet eastward from the point of beginning thence along the northern side of Arlington Ave. N. 71 W. 50 feet to the point of beginning being the same land conveyed to me by Eero Jackson.
