SEND GREETING:

WHEREAS, I, the said L. A. Mills

in and by certain promissory note in writing, of even date with these presents, am well and truly indebted to

W. H. Keith

in the full and just sum of Sixty-two hundred fifty (\$6250.00)

Dollars, to be paid on or before three years from date

with interest thereon from July 22, 1925 at the rate of 6 per cent. per annum, to be computed and paid semi-annually

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place, and the holder should place, the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses, including 10 per cent. of the indebtedness as attorney's fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

at and before the signing of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said W. H. Keith:

All that certain lot, parcel or piece of land situate, lying and being in the second ward of the city of Greenville, County and State aforesaid, on the East side of Laurens street being known and designated as lot No. 2 of the W. H. Keith property, as shown on plat made by R. E. Dalton Engineer, August 1923, and having, according to said plat the following meters and bounds, to-wit: Beginning at an iron pipe on the east side of Laurens street at joint corner of lots Nos. 1 and 2 and running thence with joint line of said lots S. 69.100. 98.7 feet to an iron pipe on a 10-foot alley; thence with said alley S. 20.38 W. 24.6 feet to an iron pipe at corner of lot No. 2; thence with line of said lot N. 69.10 W. 98.8 feet to an iron pipe on Laurens street; thence with said street N. 21.05 E. 24.6 feet to the point of beginning.
