County aforesaid, in Chick Springs Township, on the West side of Greer, on the north side of
the National Highway, and having the following metes and bounds, to-wit: Beginning at a
stake on said National Highway, corner of lot #6 and runs thence N. 8-27 E- 181-1/2 feet to a
stake on line of lot #7; thence along the line of lot #7, S. 87-50 W. 70 feet to a stake on
the back corner of lot #4; thence along the line of lot #4, S. 8-27 W. 181-1/2 feet to a stake
on said National Highway; thence with National Highway N. 87-50 E. 70 feet to the beginning
