with interest thereon from the date of the making of a mortgage executed
by the Congregational Beth Israel Synagogue of Greenville, S.C., to the said C. Zaglin
on January 19th, 1925, in the sum of \$900.00, at the rate of 8% per annum, to be
computed and paid quarterly in advance on the 1st day of October

interest thereon until paid in full; and interest not paid when due to become immediately due and payable
who may sue thereon and enforce this mortgage, and note further providing for an attorney's fee of \$100.00
added to the amount of any note to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or
any part thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference
being thereunto had, as more fully appears.

Bourne street, County and State aforesaid
and having the following metes and bounds
to-wit: Beginning at an iron pin on Townes
street at joint corner with lot with ten
foot frontage conveyed to Green by Louis
B. Thomas on June 9th, 1925, and lot herein
conveyed and running thence with said
street fifty feet to an iron pin; thence
N. 72-15 W. 146 feet to an iron pin, joint
corner of lots Nos. 2 and 3; thence S. 12 W. 48
