Jeffriesat and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold, and released, and by these Presents, do grant, bargain, sell and release unto the said W.H. Rownes Attorney for Mrs. John D. Jeffriesall that piece, parcel or tract of land in Greenville Township, County and State aforesaid about Four miles west of Greenville Court House, in Greenville Township, County and State aforesaid on waters of Saluda River, having the following metes and bounds, to wit;

Beginning at a stake on branch running thence N. 52-30 W. 400.4 feet to an iron pipe on road, thence A. 62-0 W. 438 feet to iron pipe in field, thence A. 47-39 N. 65-8-2 feet to iron pipe in field, thence S. 52-30 E. 114.2 feet to stake on branch, thence up the branch to beginning corner, center of branch being line and containing 12.9 acres, more or less, and being the same tract of land conveyed to me by J.
