interest be at any time past due and unpaid; then the whole amount evidenced by said note to become immediately due at the option of the holder hereof,
who may sue thereon and foreclose this mortgage, said note further providing for an attorney's fee of ten per cent.

besides all costs and expenses of collection, to be
added to the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or
any part thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage; as in and by the said note, reference

bargain, sell and release unto the said Mrs. Mame W. Webb

That certain piece, parcel or lot of land situate lying
and being in the County and State aforesaid, and being
in the City of Greenville, and having the follow-
ing metes and bounds, to-wit: Beginning at an iron
pin on the South side of Whitsett Street at a point
two hundred and twenty-one feet and three inches
(221' 3") West of Carolina Avenue and running thence with
said Whitsett Street 276-45' N. Fifty-five feet and five
inches (55' 5") to an iron pin at the corner of Richardson's
lot thence with Richardson's line 15-0 E. 126 feet and
1 inch (126' 1") to an iron pin on a ten ft. alley thence with said
alley N. 76-45 E. Fifty-five feet and five inches (55' 5")
to an iron pin corner of lot D, thence with line of
lot D N. 15-0 W. One hundred twenty-six feet and one inch
