with interest thereon, from date of recordation of this instrument, quarterly, at the rate of 6 per cent. per annum, to be computed and paid.

in consideration of the payment of all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note is to become immediately due at the option of the holder hereof, who may sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of ten per cent

besides all costs and expenses of collection, to be added to the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney by legal proceedings of any kind (all of which are secured under this mortgage) as in and by the said note, reference being thereto had as will more fully appear.

Dalton, Engr., April, 1925, to-wit: Commencing at an iron pipe on the west side of North Main Street, on line of property of Lucy L. Hindman; thence along west side of North Main Street S. 19-55 W. 1188 feet to an iron pipe at the northwest corner of North Main Street and Ashley Avenue; thence along the North side of Ashley Avenue N. 65-22 W. 209.3 feet to an iron pipe on line of property of A.A. Butler, et-al.; thence with said line N. 5-41 E. 1027.6 feet to a store; thence with line of Lucy L. Hindman N. 6-0 E. 219.6 feet to an iron pin; thence with line of Lucy L. Hindman et-al. S. 66-23 E. 513.3 feet to the point of beginning. Being the same lot of land conveyed to me by the said Essie G.
