Dollars, to be paid Nov. 1-1925

with interest thereon, from date at the rate of 8 per cent. per annum, to be
computed and paid Annually

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or
interest be at any time past due and unpaid; then the whole amount evidenced by said note to become immediately due at the option of the holder hereof,
who may sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of ten percent of the amount

added to the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or
any part thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage; as in and by the said note, reference
being thereto had, as will more fully appear.)

at and before the signing of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold, and released, and by these presents, do grant,
bargain, sell and release unto the said F. M. Todd

All that certain lot of land in Greenville Township, Greenville
County, South Carolina, beginning on the North side of Oregon
Street 180 feet East of Mitchell Street at corner of Lot No. 8; and
running thence N. 25° 51' feet W. 165 feet to corner of Lot No. 17; thence
S. 63° 35' W. 60 feet to corner of Lot No. 15; thence S. 25° 51' E. 165 feet to
Oregon Street corner of Lot No. 6; thence with Oregon Street N. 63° 35' E.
160 feet to the beginning corner, being Lot No. 7. Block "C" of Kanawha,
a subdivision of land represented by plan recorded in Plat Book
"F" page 131, and being the same lot of land conveyed to me by R. V.
Devane by deed dated July 8, 1925, said deed to be recorded in
