

THE STATE OF SOUTH CAROLINA,

TO ALL WHOM THESE PRESENTS MAY CONCERN:

That I, Isaac Ellison of Greenville, in the County of Greenville, and the State of South Carolina, send Greeting:

WHEREAS, I, the said Isaac Ellison in and by my certain note or obligation, bearing the 21st day of February 1925 indebted unto The Carolina Loan and Trust Company, of the City and County of Greenville, in said State (a body corporate, duly incorporated under the laws of such State), in the sum of Nine Hundred & no/100 (\$900.00) Dollars, with interest thereon at the rate of eight per centum per annum, payable monthly, from the 21st day of February A. D. 1925, according to the provisions of the Charter, By-Laws, Rules and Regulations of the said Company, in manner and form following, that is to say, that

I the said Isaac Ellison shall pay or cause to be paid to the said Company, or its certain attorneys, successors or assigns, at Greenville City aforesaid, monthly, on the 20th or before the end of the month of March 1925, and on the 20th or before the end of each month thereafter for twenty successive months, the sum of Fifteen & no/100 (\$15.00) Dollars, (1925) Dollars,

being the regular monthly installment payable on the 100 Shares of Stock, and Five & no/100 (\$5.00) Dollars, being the monthly interest on the advance (13.88) until they have been paid twenty monthly payments, and shall for the next twenty months pay the sum of Thirteen & no/100 (\$13.00) Dollars, (\$9.00) Dollars, being the regular monthly payment on said stock, and (\$4.00) Dollars, being the monthly interest on balance due); for the next twenty months the sum of Twelve & no/100 (\$12.00) Dollars, (\$4.00) Dollars, being the regular monthly payment on said stock and Three & no/100 (\$3.60) Dollars, being the monthly interest on balance due); for the next twenty months the sum of Eleven & no/100 (\$11.40) Dollars, (\$4.00) Dollars, being the monthly payment on said shares of stock and

the monthly interest on balance due); for the next twenty months pay the sum of Ten & no/100 (\$10.00) Dollars, (\$4.00) Dollars, being the monthly payment on said shares of stock and the monthly interest on balance due); for the next twenty months pay the sum of Nine & no/100 (\$9.00) Dollars, (\$4.00) Dollars, being the monthly interest on balance due.)

Each of the above payments to be made on the 20th or before the last day of each month, and shall thereafter surrender to the Company the said Nine (9) shares of stock and the certificate thereof, the amount at such time paid shares by me to be credited as a payment upon the advance or loan made I, the said Isaac Ellison and shall pay or cause to be paid all taxes which may be duly imposed upon or charged against I the said Isaac Ellison in accordance with the Charter, By-Laws, Rules and Regulations, as in and by the said note or obligation, and the condition thereunder written, reference being thereunto had, will more fully appear.

NOW, KNOW ALL MEN, That I, the said Isaac Ellison in consideration of the said debt and sum of money as aforesaid, and for the better securing the payment thereof to the said The Carolina Loan and Trust Company, according to the terms of said note or obligation, and also in consideration of the further sum of Five Dollars to me the said Isaac Ellison in hand well and truly paid by the said The Carolina Loan and Trust Company, at and before the sealing and delivery of these Presents, (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said The Carolina Loan and Trust Company, all that tract or parcel of land, situated in the County of Greenville, State of South Carolina, and described as follows:

Known as lot no. 35 on plat of (Fide & Patton Land) Company and recorded in R. M. Co. office for Greenville County in plat Book "E" page 249. Said lot having a frontage of fifty (50) feet on the south side of Weatherly Drive with a depth in parallel lines of 210 feet being the same lot conveyed to me by Fide & Patton Land Company by deed dated 1st day of August 1925 to be recorded.
