

THE STATE OF SOUTH CAROLINA,

TO ALL, WHOM THESE PRESENTS MAY CONCERN:

That I, Queen Ann White of Greenville, in the County of Greenville, and the State of South Carolina, send Greeting:

WHEREAS, I, the said Queen Ann White in and by my I am certain note or obligation, bearing the 13th day of March 1925, indebted unto The Carolina Loan and Trust Company, of the City and County of Greenville, in said State (a body corporate, duly incorporated under the laws of such State), in the sum of Two Thousand + 20/100 (\$2000.00) Dollars, with interest thereon at the rate of eight per centum per annum, payable monthly, from the 13th day of March A. D. 1925, according to the provisions of the Charter, By-Laws, Rules and Regulations of the said Company, in manner and form following, that is to say, that

I the said Queen Ann White shall pay or cause to be paid to the said Company, or its certain attorneys, successors or assigns, at Greenville City aforesaid, monthly, on the 20th or before the end of the month of March 1925, and on the 20th or before the end of each month thereafter for twenty successive months, the sum of Thirty-Three + 33/100 (\$33.33) Dollars, (\$20.00) Dollars, being the regular monthly installment payable on the Twenty (20) Shares of Stock, and Thirteen + 33/100 (\$13.33) Dollars, being the monthly interest on the advance or loan) until there have been paid twenty monthly payments, and shall for the next twenty months pay the sum of Thirty + 67/100 (\$30.67) Dollars, (\$20.00) Dollars, being the regular monthly payment on said stock, and Ten + 67/100 (\$10.67) Dollars, being the monthly interest on balance due); for the next twenty months the sum of Twenty-Eight + 20/100 (\$28.00) Dollars, (\$20.00) Dollars, being the regular monthly payment on said stock and Eight + 20/100 (\$8.00) Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of Twenty-five + 33/100 (\$25.33) Dollars, (\$20.00) Dollars, being the monthly payment on said shares of stock and Five + 33/100 (\$5.33) Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of Twenty-Two + 67/100 (\$22.67) Dollars, (\$20.00) Dollars, being the monthly payment on said shares of stock and Two + 67/100 (\$2.67) Dollars, being the monthly interest on balance due.)

Each of the above payments to be made on the 20th or before the last day of each month, and shall thereafter surrender to the Company the said Twenty (20) shares of stock and the certificate thereof, the amount at such time paid shares by I, the said Queen Ann White

and shall pay or cause to be paid all fines which may be duly imposed upon or charged against I the said Queen Ann White in accordance with the Charter, By-Laws, Rules and Regulations, as in and by the said note or obligation, and the condition thereunder written, reference being hereunto had will more fully appear

NOW, KNOW ALL MEN, That I the said Queen Ann White in consideration of the said debt and sum of money as aforesaid, and for the better securing the payment thereof to the said The Carolina Loan and Trust Company, according to the terms of said note or obligation and also in consideration of the further sum of Five Dollars to me the said Queen Ann White in hand well and truly paid by the said The Carolina Loan and Trust Company, at and before the sealing and delivery of these Presents, (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said The Carolina Loan and Trust Company, all that tract or parcel of land, situated in the County of Greenville, State of South Carolina, and described as follows:

In or near the corporate limits of the City of Greenville on the South West side of said City bounded by lands of the Columbia and Greenville Railroad of the Southern Railway Company, lot now or formerly owned by W.H. Poole and lands now or formerly of J.W. Brooks and others; the said lot containing one-half (1/2) acre, more or less, and being the same lot conveyed to Essie Inman, by J.H. Garrett by deed bearing date of April 22nd, 1911, and recorded in Volume, 11, Page 474, R. M. C. Office for Greenville County (See Judgment Roll No. C-535) now on file in the office of the Clerk of Court for Greenville County and being the same lot conveyed to me by Essie Inman by deed dated February 5th - 1924, and recorded in Volume 82, Page 392, R. M. C. Office for Greenville County.
