That I, C. F. Putman, of Greenville, in the County of Greenville, and the State of South Carolina, send Greeting:

WHEREAS, I, the said C. F. Putman, in and by my certain note or obligation, bearing the 1st day of August 1925

I am indebted unto The Carolina Loan and Trust Company, of the City and County of Greenville, in said State (a body corporate, duly incorporated under the laws of such State), in the sum of Thirty Three Hundred and no/100 (\$3300.00) Dollars,

with interest thereon at the rate of eight per centum per annum, payable monthly, from the 1st day of August A. D. 1925, according to the provisions of the Charter, By-Laws, Rules and Regulations of the said Company, in manner and form following, that is to say, that I

the said C. F. Putman, shall pay or cause to be paid to the said Company, or its certain attorneys, successors or assigns, at Greenville City aforesaid, monthly, on the 20th or before the end of the month of August 1925, and on the 20th or before the end of each month thereafter for twenty successive months, the sum of Fifty Five and no/100 (\$55.00) Dollars,

being the regular monthly installment payable on the Thirty Three Shares of Stock, and Twenty Two and no/100 (\$22.00) Dollars, being the monthly interest on the advance or loan) until there have been paid twenty monthly payments, and shall for the next twenty months pay the sum of Fifty and no/100 (\$50.00) Dollars, (\$33.00) Dollars, being the regular monthly payment on said stock, and Seventeen and no/100 (\$17.00) Dollars, being the monthly interest on balance due);

for the next twenty months the sum of Forty Six and no/100 (\$46.20) Dollars, being the regular monthly payment on said stock and Thirteen and no/100 (\$13.20) Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of Forty one and no/100 (\$41.80) Dollars, (\$33.00) Dollars, being the monthly payment on said shares of stock and

Eight and no/100 (\$8.80) Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of Thirty Seven and no/100 (\$37.40) Dollars, (\$33.00) Dollars, being the monthly payment on said shares of stock and

Four and no/100 (\$4.40) Dollars, being the monthly interest on balance due.) Each of the above payments to be made on the 20th or before the last day of each month, and shall thereafter surrender to the Company the said 33 shares of stock and the certificate thereof, the amount at such time paid shares by me to be credited as a payment upon the advance or loan made, the said C. F. Putman.

Putman, in accordance with the Charter, By-Laws, Rules and Regulations, as in and by the said note or obligation, and the condition thereunder written, reference being thereunto had will more fully appear.

NOW, KNOW ALL MEN, That I the said C. F. Putman, in consideration of the said debt and sum of money as aforesaid, and for the better securing the payment thereof to the said The Carolina Loan and Trust Company, according to the terms of said note or obligation, and also in consideration of the further sum of Five Dollars to me

Putman, in hand well and truly paid by the said The Carolina Loan and Trust Company, at and before the sealing and delivery of these Presents, (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said The Carolina Loan and Trust Company, all that tract or parcel of land, situated in the County of Greenville, State of South Carolina, and described as follows:

In the City of Greenville, having the following metes and bounds to wit: - Beginning on the north side of Atkins Street 140 feet from corner of Atkins and Hammett Streets, and running thence N. 80. 8 W. 60 feet; thence N. 12. 5 E. 168 feet 9 inches to P. C. Parkins line, thence S. 69 E. 20 feet 9 inches to Marchbanks & Jones corner, thence S. 9-52 W. 150 feet to the beginning corner, being Lot No. 7 according to plat recorded in Plat Book A. at page 535, and the same land conveyed to me by J.
