TO ALL, WHOM THESE PRESENTS MAY CONCERN:

That Mary L. Pittman of Greenville, in the County of Greenville, and the State of South Carolina, send Greeting:

WHEREAS, Mary L. Pittman, the said Mary L. Pittman in and by me certain note or obligation, bearing the 15th day of September 1925 indebted unto The Carolina Loan and Trust Company, of the City and County of Greenville, in said State (a body corporate, duly incorporated under the laws of such State), in the sum of Two Hundred Fifty & No/100 (\$250.00) Dollars, with interest thereon at the rate of eight per centum per annum, payable monthly, from the 15th day of September A. D. 1925, according to the provisions of the Charter, By-Laws, Rules and Regulations of the said Company, in manner and form following, that is to say, that

being the regular monthly installment payable on the Two one-half Shares of Stock, and one & 67/100 (\$1.67) Dollars, being the monthly interest on the advance or loan) until there have been paid twenty monthly payments, and shall for the next twenty months pay the sum of _____ Dollars, (_____ Dollars, being the regular monthly payment on said stock, and _____ Dollars, being the monthly interest on balance due);

for the next twenty months the sum of _____ Dollars, (_____ Dollars, being the regular monthly payment on said stock and _____ Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of _____ Dollars, (_____ Dollars, being the monthly payment on said shares of stock and _____ Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of _____ Dollars, (_____ Dollars, being the monthly payment on said shares of stock and _____ Dollars, being the monthly interest on balance due.)

Each of the above payments to be made on the 20th or before the last day of each month, and shall thereafter surrender to the Company the said Two one-half shares of stock and the certificate thereof, the amount at such time said shares by me to be credited as a payment upon the advance or loan made to the said Mary L. Pittman and shall pay or cause to be paid all fines which may be imposed upon or charged against me the said Mary L. Pittman in accordance with the Charter, By-Laws, Rules and Regulations, as in and by the said note or obligation, and the condition hereunder written, reference being thereunto had will more fully appear.

NOW, KNOWING ALL the contents of the said note or obligation, and for the better securing the payment thereof to the said The Carolina Loan and Trust Company, according to the terms of said note or obligation, and also in consideration of the further sum of Five Dollars to me the said Mary L. Pittman in hand well and truly paid by the said The Carolina Loan and Trust Company, at and before the sealing and delivery of these Presents, (the receipt whereof is hereby acknowledged), I do hereby grant, bargain, sell and release, and by these Presents, do grant, bargain, sell and release unto the said The Carolina Loan and Trust Company, all that tract or parcel of land, situated in the County of Greenville, State of South Carolina, and described as follows:

On the South side of Grove Road, commencing at an iron pin on Grove Road 305 feet from the West side of Augusta Street, thence along the south side of Grove Road, S. 45-27 W. 60 feet to an iron pipe, thence nearly parallel to Augusta Street S. 47-52 E. 180 feet to an iron pipe on rear line, thence along rear line parallel to Grove Road N. 45-27 E 60 feet to an iron pipe, thence nearly parallel to Augusta Street, N. 47-52 W. 180 feet to the point of beginning, said lot being known as Lot No. 7 Block N. as shown on plat recorded in Plat Book C. Page 176, R. M. C. Office for Greenville County, South Carolina and being the same lot conveyed to me by Emma Memmich by deed recorded in Deed Book 83, Page 450, R. M. C. Office for Greenville County South Carolina.
