TO ALL WHOM THESE PRESENTS MAY CONCERN:

That *W. Charlotte Tripp Halter* of Greenville, in the County of Greenville, and the State of South Carolina, send Greeting:

WHEREAS, *W. Charlotte Tripp Halter*, the said *W. Charlotte Tripp Halter* in and by *Mary Keenan Smith* certain note or obligation, bearing the *16th* day of *September* 192*5* indebted unto The Carolina Loan and Trust Company, of the City and County of Greenville, in said State (a body corporate, duly incorporated under the laws of such State), in the sum of *One Thousand and no/100 (\$1,000.00)* Dollars, with interest thereon at the rate of eight per centum per annum, payable monthly, from the *16th* day of *September* A. D. 192*5*, according to the provisions of the Charter, By-Laws, Rules and Regulations of the said Company, in manner and form following, that is to say, that

being the regular monthly installment payable on the *1.0* Shares of Stock, and *\$6.67* Dollars, being the monthly interest on the advance (loan) until there have been paid twenty monthly payments, and shall for the next twenty months pay the sum of *\$15.33* Dollars, (*\$10.00* Dollars,
