TO ALL WHOM THESE PRESENTS MAY CONCERN:

That We Fred Drazier and Mary J. Drazier of Greenville, in the County of Greenville, and the State of South Carolina, send Greeting:

WHEREAS, We, the said Fred Drazier and Mary J. Drazier in and by Our certain note or obligation, bearing the 7th day of November 1925

We are indebted unto The Carolina Loan and Trust Company, of the City and County of Greenville, in said State (a body corporate, duly incorporated under the laws of such State), in the sum of Twenty-Eight Hundred + no/100 (\$2800.00) Dollars, with interest thereon at the rate of eight per centum per annum, payable monthly, from the 7th day of November A. Drazier shall pay or cause to be paid to the said Company, or its certain attorneys, successors or assigns, at Greenville City aforesaid, monthly, on the 20th or before the end of the month of November 1925, and on the 20th or before the end of each month thereafter for twenty successive months, the sum of \$46.67

Dollars, \$28.00 Dollars, being the regular monthly installment payable on the Twenty-Eight (28) Shares of Stock, and \$18.67

Dollars, being the monthly interest on the advance or loan) until there have been paid twenty monthly payments, and shall for the next twenty months pay the sum of \$42.93

Dollars, being the regular monthly payment on said stock, and \$14.00 Dollars, being the monthly interest on balance due); for the next twenty months the sum of \$29.20

( \$28.00 Dollars, being the regular monthly payment on said stock and \$11.20

Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of \$35.47

Dollars, being the monthly payment on said shares of stock and \$7.47

Dollars, being the monthly interest on balance due.) \$31.79

NOW, KNOW ALL MEN, That We the said Fred Drazier and Mary J. Drazier in consideration of the said debt and sum of money as aforesaid, and for the better securing the payment thereof to the said The Carolina Loan and Trust Company,

according to the terms of said note or obligation, and also in consideration of the further sum of Five Dollars to us the said Fred Drazier and Mary J. Drazier

in hand well and truly paid by the said The Carolina Loan and Trust Company, at and before the sealing and delivery of these Presents, (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said The Carolina Loan and Trust Company, all that tract or parcel of land, situated in the County of Greenville, State of South Carolina, and described as follows:

In the City of Greenville beginning at the Northeast corner of Ann and Manly streets, thence with North side of Ann street N. 77 E. 31 feet, thence N. 14-45 W. 100 feet, thence S. 77 W. 31 feet to Manly street, thence with Manly street S. 14-45 E. 100 feet to the beginning corner, being the same land conveyed to us by John Cassy, deed dated January 15th, 1917, recorded in Deed Book 46, page 54, R. M. C. Office for Greenville County.
