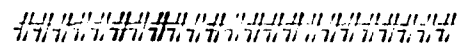
THIS INDENTURE, made this 10th day of December A. D. 1924.

WITNESSETH, Whereas, the said party of the first part is indebted to said MECHANICS BUILDING AND LOAN ASSOCIATION in the sum of
Twelve hundred no/100
Dollars, money loaned this day, with interest thereon from this date at the rate of eight
per cent. per annum, payable weekly,
the payment whereof the said party of the first part is anxious to secure:

Now, therefore, in consideration of the premises, and in further consideration of one dollar to him in hand paid, the receipt whereof is hereby acknowledged,
the said party of the first part has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the said party of the second
part all that certain piece, parcel and lot of land lying in Greenville County, in the State aforesaid, as follows, to-wit:

In Greenville township, being a portion of lot No. 33 on plat of property of Looper & Vorn
made by R.E. Dalton, Engineer, and recorded in Plat Book F, page 77. Beginning at a stake on
Gordon Street, corner of lot No. 35 and running thence with line of lot No. 35, S. 10-15 E.
200 feet to stake, corner of lot No. 32; thence with line of lot No. 32, 47.2 feet to stake;
thence in a northeasterly direction 200 feet, more or less, to stake on Gordon Street; thence
with Gordon Street S. 79-45 W. 73.1 feet to beginning corner, being the same conveyed to J.A.-
O'Neal by E. Linkenauger by deed dated 1st, December, 1924.
