until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or
interest be at any time past due and unpaid; then the whole amount evidenced by said note to become immediately due at the option of the holder hereof,
who may sue thereon and for costs of this mortgage and note further providing for an attorney's fee of ten per cent.

besides all costs and expenses of collection, to be
added to the amount due on said note, to be collectible as a part thereof; if the same be placed in the hands of an attorney for collection, or if said debt, or
any part thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage; as in and by the said note, refer-

bargain, sell and release unto the said W. A. Wallace

and being known and designated as tract no. 8 on
plot of property of Greenville Realty and Investment
Company, made by R. E. Dalton Esqr. Decem. 31st 1923 duly
recorded in R. M. O. Office for Greenville County and
