Dollars, to be paid one year after date.

with interest thereon from the day of at the rate of 8 per cent. per annum, to be  
computed and paid quarterly

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or  
interest be at any time past due and unpaid; then the whole amount evidenced by said note to become immediately due at the option of the holder hereof,  
who may sue thereon and foreclose this mortgage; said note further provides for an attorney fee of ten percent.

RECORD 1944 besides all costs and expenses of collection, to be  
added to the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or  
any part thereof, be collected by an attorney or by legal proceedings of any kind, all of which is secured under this mortgage; as in and by the said note, refer-  
ence being thereto had, as will more fully appear.

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold, and released, and by these Presents, do grant,  
bargain, sell and release unto the said William Goldsmith,

all that certain piece, parcel or lot of land  
situate, lying and being in the County  
and State aforesaid, in Ward 2 of the city  
of Greenville, on the north side of East  
Carle Street, and having the following  
measures and bounds to wit: Beginning at  
a stake on the north side of East  
Carle Street, a distance of 180 feet East  
of the northeast corner of Carle and  
Bennett Streets, and running thence  
with Carle Street, S. 11-20 E. 68 feet to a  
stake on Carle Street, thence N. 18-30 E.  
139.2 feet more or less, to a stake, thence  
N. 66-15 W. 60.3 feet, more or less to a stake  
thence S. 18-13 W. 145 feet, more or less, to the  
beginning corner, on Carle Street, known and  
designated as lot No 22 section "2" on plat  
of the Stone Land Company, said plat  
recorded in Plat Book "A" page 337 R.M.C.  
Office for Greenville County. Being  
the same lot of land conveyed to me  
by B. D. Richardson by deed dated May 4th
