WHEREAS, I., the said J. Orange E. Hill,
 in and by my certain personal property,
 even date with these presents, Aug. 26,
1925, dealt with Albert P. Bailey and Wm. E. Rason,
 in the full and just sum of Three hundred Fifty Dollars (\$250.00),
 Dollars, to be paid in monthly installments of \$15.00 each,
commencing on Sept. 26, 1925 and continuing monthly
on the 26th day of each and every month until
paid in full,
 with interest thereon, from Aug. 26, 1925 at the rate of eight per cent. per annum, to be
 computed and paid on the 26th day,
 until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or
 interest be at any time past due and unpaid; then the whole amount evidenced by said note, to become immediately due at the option of the holder hereof,
 who may sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of ten per cent. of
amount due, besides all costs and expenses of collection, to be
 added to the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold, and released, and by these Presents, do grant,

bargain, sell and release unto the said Albert P. Bailey and Wm. E. Rason,

their heirs and assigns forever, all that certain
 piece, parcel, lot or tract of land lying, situated
 and being in Greenville Township, State and
 County aforesaid, in sub-division known and
 called "McLary's" and being known and
 designated as lot No. 15 of said sub-division,
 and having a frontage on McLary Street of
 50 feet and a depth along Edwards St. of
 150 feet, reference to said plat, which is
 recorded in Office of Register of Deeds
 Conveyances for Greenville County, South
 Carolina in Plat Book "F" at page 298, is
 granted for further description. This is the
 same property this day conveyed to me by said
