with interest thereon, from Date at the rate of 10% per cent. per annum, to be  
 computed and paid ~~Accruing annually~~  
 until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or  
 interest be at any time past due and unpaid; then the whole amount evidenced by said note..... to become immediately due at the option of the holder hereof,  
 who may sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of.....

10% besides all costs and expenses of collection, to be  
 added to the amount due on said note....., to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or  
 any part thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage; as in and by the said note....., refer-  
 ence being thereunto had, as will more fully appear.

according to the terms of said note....., and also in consideration of the further sum of Three Dollars, to me, the said

in hand well and truly paid by the said Leroy A. Werts

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold, and released, and by these Presents, do grant,  
 bargain, sell and release unto the said Leroy A. Werts.

All that certain lot piece or parcel of land situate  
 lying and being in the County of Greenville, State  
 of South Carolina in the fifth ward of the  
 City of Greenville known and designated as  
 lot no. Three (3) on a plat of my property made  
 by G. A. Schuyler, dated September 14, 1925 and having  
 according to said plat the following metes and  
 bounds to-wit: Beginning at an iron pin on  
 the West side of Green Avenue on the Southeast  
 corner of lot no two (2) as shown on said plat  
 Said pin being two hundred and eight and four  
 hundred feet Southeastward from Jenkins Street and  
 running thence N. 67 deg. 30 min. W. one hundred  
 (100) feet along line of lot no. two to an iron  
 pin on line of lot no. seven (7); thence S. 27 deg.  
 W. fifty (50) feet (of which forty-nine feet is  
 along the rear line of lot no. Seven and one  
 (1) foot is along the rear line of lot no. eight)  
 to an iron pin on the rear line on the N.W.  
 corner of lot no. four (4); thence along line of last  
 mentioned lot S. 67 deg. 30 min. E. one hundred (100)  
 feet to an iron pin on Green Avenue; thence  
 along said Avenue N. 27 deg. E. fifty (50) feet  
 to the beginning.
