besides all costs and expenses of collection, to be added to the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage; as in and by the said note, reference being thereunto had, as will more fully appear.

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold, and released, and by these Presents, do grant, bargain, sell and release unto the said No. V. Hughey, his heirs and assigns:

All that certain piece parcel or lot of land in Greenville Township near the city of Greenville in the subdivision known as Kanatenah, known as Lot No. 1 in Block L. on revised Plat of the said property to be recorded in R. M. S. Office for Greenville County, said lot has the following meters and bounds. Beginning at a stake on the North side of Oregon Street at the corner of Fuller Street and running thence along Oregon Street, 60 feet to stake at the corner of lot No. 2. thence along said lot, 165 feet to stake on rear line of the Lawton property, thence along said line 60 feet to stake on said Fuller Street, thence along Fuller Street 165 feet to the beginning corner. The grantee by acceptance of this deed covenants that he will not construct on said lot any surface closet nor toilet, but only septic tanks or other sanitary sewers as may be provided by the grantee.
