Dollars, to be paid me as follows: Thirteen and 25/100 Dollars (\$13.25)
on December 31st, 1925 and \$31.25 on the 21st day of
each and every consecutive month thereafter
until paid in full

with interest thereon, from date at the rate of 7 per cent. per annum, to be
computed and paid. January - December

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or
interest be at any time past due and unpaid; then the whole amount evidenced by said note to become immediately due at the option of the holder hereof,
who may sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of \$100.00

according to a survey and plat made by C. M. Durman
