with interest thereon, at the rate of 8 per cent. per annum, to be  
computed and paid of annually

when paid in full; all interest not when due to bear interest at the same rate as principal; and if any portion of principal or  
interest be at any time past due and unpaid; then the whole amount evidenced by said note to become immediately due at the option of the holder hereof,

who may sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of 10% of the above amount for  
**collection in case this note or any part of it is collected by an attorney, and in addition**  
**thereto a reasonable attorneys fee for any litigation concerning this note** besides all costs and expenses of collection, to be  
added to the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or  
any part thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage; as in and by the said note, refer-  
ence being thereunto had, as will more fully appear.

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold, and released, and by these Presents, do grant,

bargain, sell and release unto the said A.K. Manos, his heirs and assigns "All that certain piece, parcel  
or tract of land in Greenville Township, Greenville County, State of South Carolina, about  
two and one-half miles West of Greenville Court House, near the Fasley Bridge Road, known  
as Lot No. 23 of Block C, on plat of property of Julia D. Charles recorded in Plat Book E,  
page 209: Beginning at a stake at the intersection of Gordon Street and Florida Avenue and  
running thence with Florida Avenue S. 9-30 E. 80.98 feet to stake, corner of lot No. 21;  
thence with line of lot No. 21 in a westerly direction 291.12 feet to stake, joint corner  
of lots Nos. 20, 21 and 22 and 23; thence with line of lot No. 22 in a northerly direction  
80 feet to stake Gordon Street N. 71 W. 300 feet to the beginning corner.
