at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold, and released, and by these Presents,
do grant, bargain, sell and release unto the said *The Woodside National Bank*:

All that certain piece, parcel or lot of land situated, lying and being in the state of South Carolina and county of Greenville and in the town of West Greenville on the north side of Pendleton street and designated on plat of land of Furman and Hainsworth as lot No. nineteen; having a frontage of fifty feet on Pendleton street and extending back along parallel lines one hundred ninety-eight feet more or less to line of alley as laid out on said plat and bounded on the east by lot No. Twenty and on the west by lot No. Eighteen.

This is the same lot of land heretofore conveyed to W. H. Withered by deed of J. W. Rains, dated September 7th, 1921, and recorded in Book 74 at page 53 in the R. M. C. office for said county and state to which deed reference is hereby made.
