WHEREAS, *I*, the said *Aubrey R. Gregory*

in and by certain *my Promissory Note* note in writing, of even date with these presents, *me* well and truly indebted to

in the full and just sum of *Five thousand (\$5,000.00)*

Dollars, to be paid *one year after date*

*so may I*

with interest thereon from *date* at the rate of *7* per cent. per annum, to be computed and paid *Semi-Annually*

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note after maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interest to place, and the holder should place, the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses, including 10 per cent. of the indebtedness as attorney's fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

at and before the signing of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said *Harriett D. Smith* All that certain lot or parcel of land

situate lying and being in Greenville Township, County and State aforesaid, near the City of Greenville, known and designated as Lot No. 56 of the subdivision known as Augusta Circle as shown on a plat of record in the R.M.C. Office for Greenville County, S.C., in Plat Book F, page 23, and having, according to said plat, the following metes and bounds, to-wit:-  
Beginning at an iron pin on the South side of Augusta Drive, and running thence with joint line of lots 55 and 56, S. 21-35 W. 184.7 feet to iron pin in line of Lot 58; thence with line of lot No. 58, N. 71-35 W. 80 feet to iron pin in line of said lot, joint corner of lots 56 and 57; thence with joint line of lots 56 and 57, N. 21-35 E. 163.9 feet to iron pin on Augusta Drive; thence with said Augusta Drive S. 86 E. 84 feet to the point of beginning.
