I, Stella B Williams  
SEND GREETING:

WHEREAS, I, Stella B Williams  
in and by certain, *promissory* note in writing, of  
even date with these presents, *Mamie Adams Wickliffe* well and truly indebted to  
in the full and just sum of *Eight hundred (\$800.00)*  
Dollars, to be paid *in monthly installments of \$50.00*

with interest thereon from *date* at the rate of *7* per cent. per annum, to be  
computed and paid *monthly*  
until paid in full; all interest not paid when due to bear interest at the same rate as principal and if any portion of principal or interest be at  
any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon  
and foreclose this mortgage; and in case said note after maturity should be placed in the hands of an attorney for suit or collection, or if before its maturity  
it should be deemed by the holder thereof necessary for the protection of his interest to do so, and the holder should place, the said note or this mortgage in the  
hands of an attorney for any legal proceedings then and in either of said cases the mortgagor promises to pay all costs and expenses, including 10  
per cent. of the indebtedness as attorney's fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

NOW, KNOW ALL MEN, That *Stella B Williams*  
in consideration of the said debt and sum of money, *for the better securing the payment thereof to the said Mamie Adams Wickliffe*  
according to the terms of the said note, and also in consideration of the further sum of *Three Dollars*, to *me*, the said *Stella B Williams*  
*Mamie Adams Wickliffe* in hand well and truly paid by the said *Mamie Adams Wickliffe*  
at and before the signing of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant,  
bargain, sell and release unto the said *Mamie Adams Wickliffe*

All that piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, and in Butler Township, on the northern side of Woods Crossing Road, containing 2.60 acres, more or less, and having according to a plat thereof prepared by Dalton and Neves, Engineers, October 1928, the following metes and bounds, to-wit: Beginning at a point in the center of said Woods Crossing Road, corner of Greenville Airport property and running thence along the center of said Woods Crossing Road in a westerly direction along an arc, the chord of which is S. 82-09 W. 230.8 feet to a point in the center of said Woods Crossing road corner of the Harvley property, and thence along the line of the Harvley property N. 12-20 E. 20 feet to an iron pin in the northern edge of said Woods Crossing Road; thence still along the line of the Harvley Property N. 12-20 E. 542 feet to an iron pin; thence still along the line of the Harvley property N. 89-15 E. 132 feet to an iron pin; thence S. 88-20 E. 82.5 feet to an iron pin corner of Greenville Airport property; thence along the line of said Greenville Airport property S. 11-47 W. 508 feet to an iron pin in the northern edge of said Woods Crossing Road; thence still along the line of said Greenville Airport property S. 11-47 W. 20 feet to the point of beginning, and being the same lot of land conveyed to the mortgagor herein by deed of Mamie Adams Wickliffe, to be recorded.

It is understood and agreed that the within mortgage and the note which the same secures is junior in rank to a certain note and mortgage executed this day by Stella B. Williams to Alester G. Furman, in the sum of Three thousand (\$3,000.00) Dollars, and is to constitute a second lien upon the premises herein described.
